Diamond Star Ranch is a gated shared amenity ranch community located within close proximity to Vail, Beaver Creek, and the limitless amenities and recreational resources found in Colorado's Eagle Valley. The ranch is easily accessed and sits seven miles east of the Vail Valley Jet Center and Eagle County Regional Airport.

Improvements on Eagle River Meadows include a recently constructed 4,250± square foot garage featuring exposed trusses, five bays including a pull-through bay, paved floors, paved exterior driveway, and parking area, LED lighting, and propane heat. The garage was constructed to meet demanding standards and will serve as an asset to new ownership moving forward. A modest 1,950± square foot barn is also located on the property and can be utilized as desired.



Seclusion and privacy are paramount at Diamond Star Ranch. Access to Diamond Star is controlled by an electronic security gate and a bridge crossing the river. Owners here have access to numerous amenities, including an equestrian center, lodge with guest suites and pool, excellent big game hunting on thousands of acres of private land, roughly three miles of private angling on the Eagle River, as well as miles of developed horse and OHV riding trails.

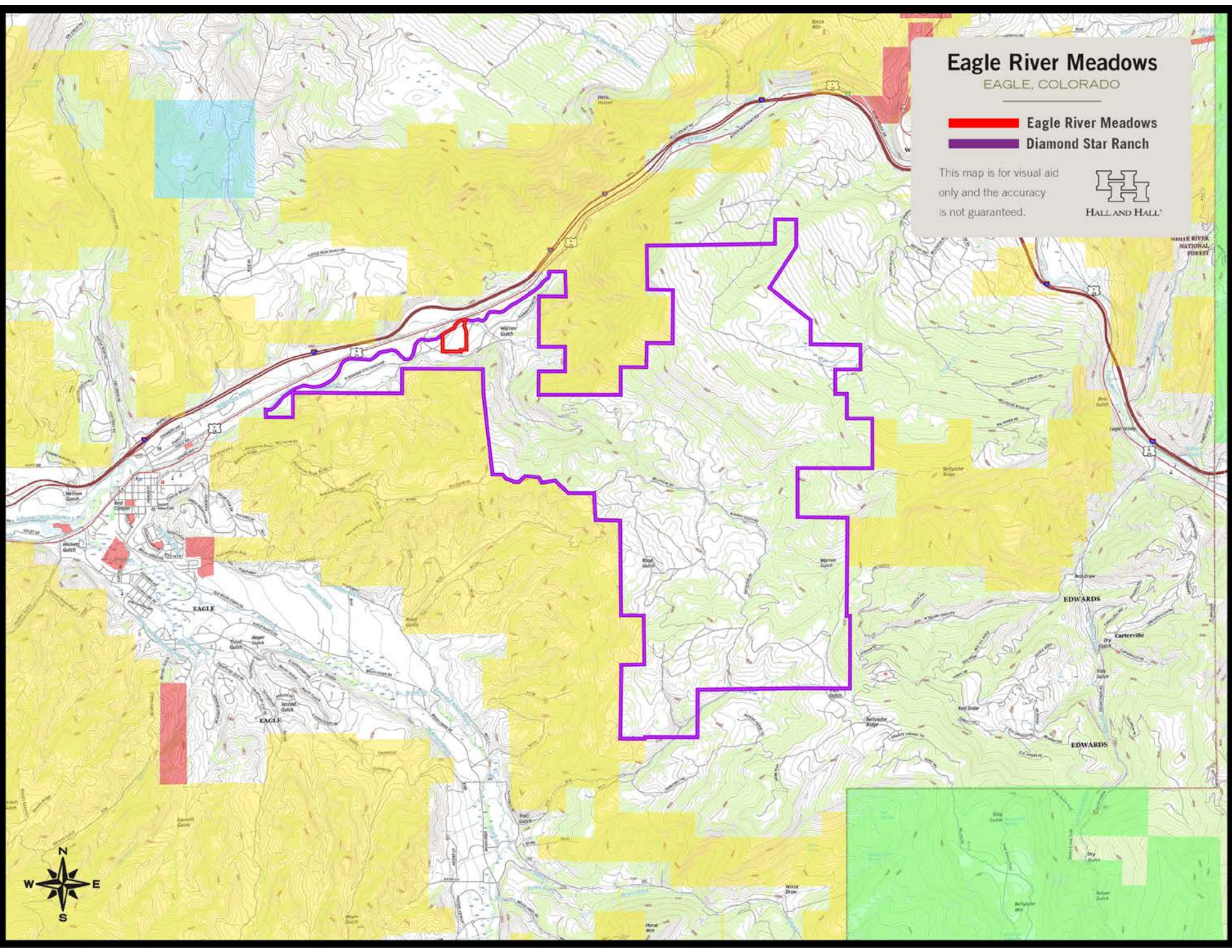

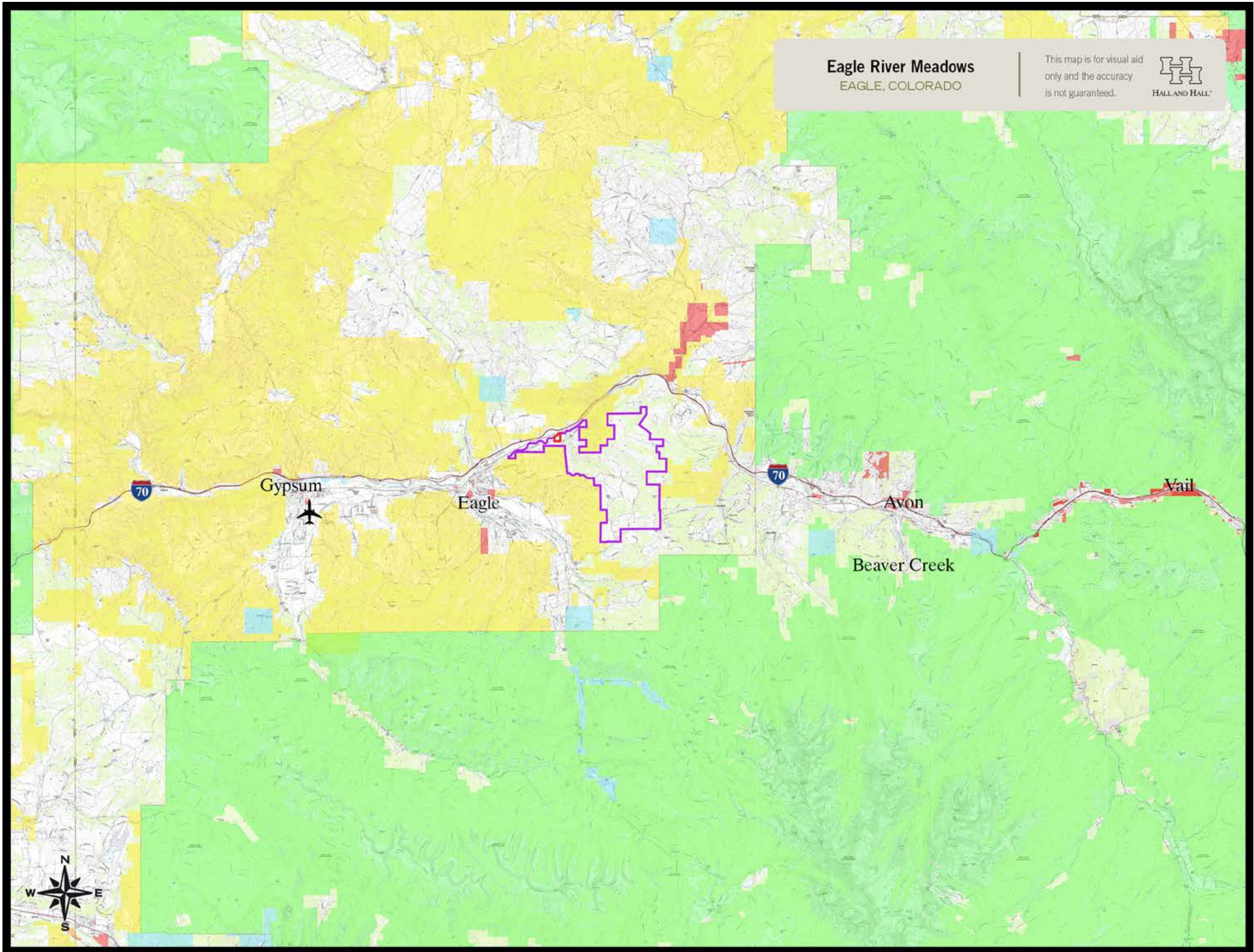

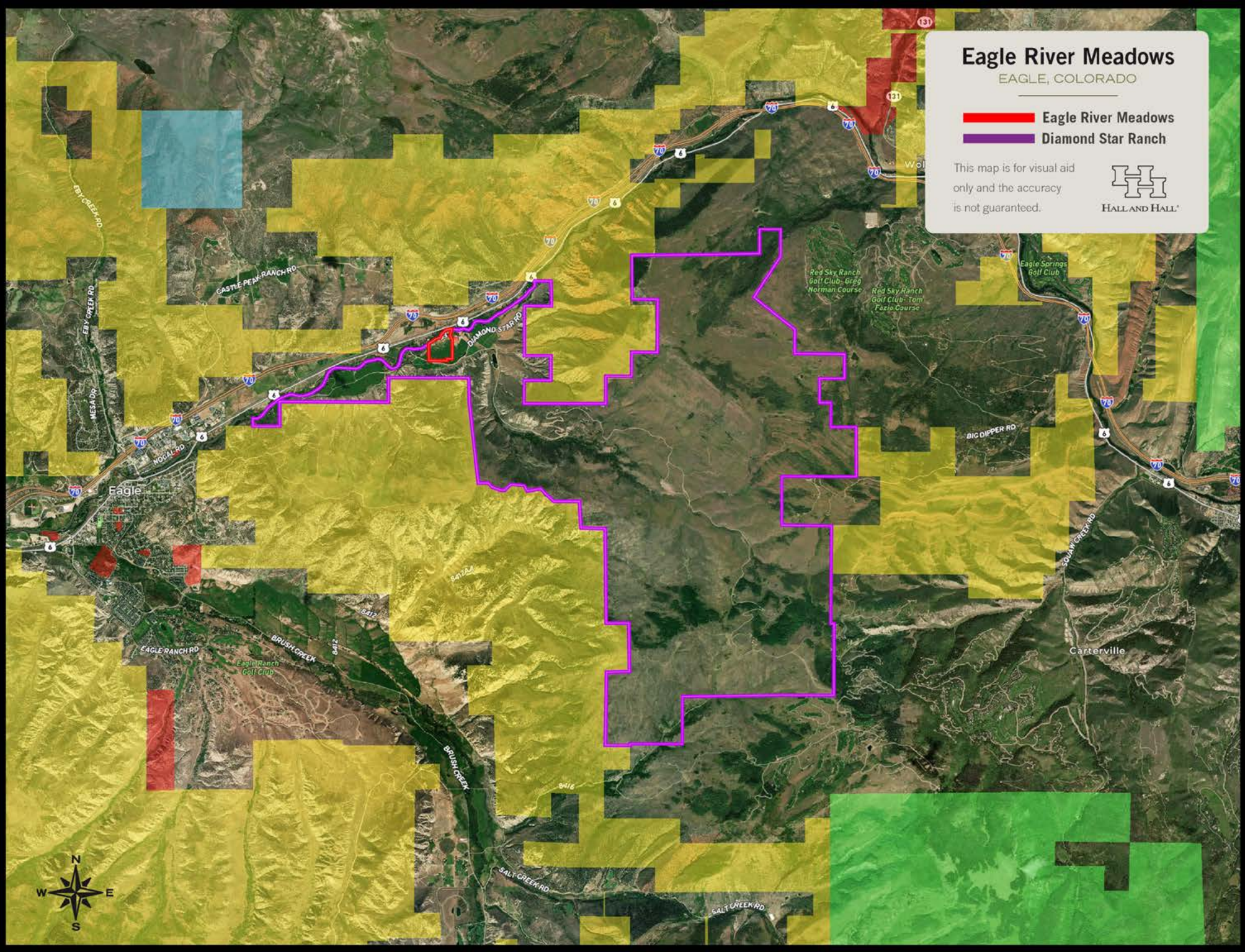
