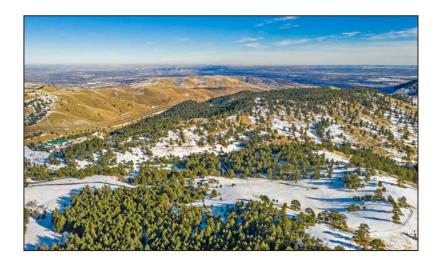
EXECUTIVE SUMMARY

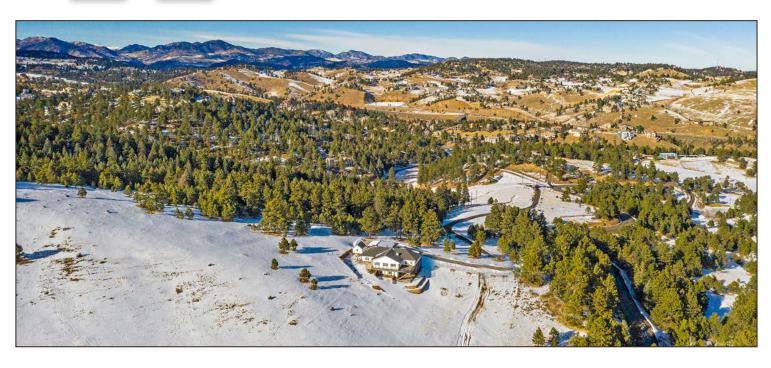
