Situated about 3.3 miles South 36° West from the City of Paris, in the County of Lamar, State of Texas, a part of the Daniel Rattan Survey #780 and being a called 60.517 acre tract (save and except 10.914 acres) conveyed to Sammy L. White by deed recorded in Vol. 1667, Page 115 of the Official Public Records of said County and State.

Beginning at a bois d'arc post found at the Northeast corner of the 60.517 acre tract and being the Southeast corner of a called 46.12 acre tract conveyed to Jason Tomblin by deed recorded in Doc.#074553-2009 of said Official Public Records and being in the West boundary line of County Road #22300.

Thence S 00°18'25" W along the East boundary line of the 60.517 acre tract and along the West boundary line of said County Road a distance of 1248.80' to a 1/2" iron pin found at the Southeast corner of the 60.517 acre tract and the Northeast corner of a called 100.80 acre tract conveyed to Dedrick Stiles by deed recorded in Vol. 738, Page 98 of said Deed Records;

Thence S 89°45'38" W along a fence a distance of 1993.73' to a 1/2" iron pin found at the Southerly Southwest corner of the 60.517 acre tract and the Southeast corner of the residue of a called 57 acre Tract 2 conveyed to H.C. Reaves by deed recorded in Vol. 526, Page 722 of said Deed Records;

Thence N 01°00'16" W along a fence a distance of 330.55' to a 3/8" iron pin found at the Northeast corner of said 57 acre residue tract and being the Southeast corner of a called 10.914 acre tract conveyed to James M. Cleere et ux by deed recorded in Vol. 846, Page 294 of the Real Property Records of said County and State:

Thence N 00°43'08" W along a fence a distance of 448.37' to a 3/8" iron pin found at the Northeast corner of the 10.914 acre tract and being in the South boundary line of a called 19.5 acre tract conveyed to Michael Redus by deed recorded in Vol. 1137, Page 282 of said Official Public Records;

Thence S 89°47'15" E along a fence and passing a wood post found at a distance of 747.99' and continuing on for a total distance of 790.08' to a point in a creek;

Thence N 12°52'01" W along said creek a distance of 496.08' to the Northerly Northwest corner of the 60.517 acre tract and being the Northeast corner of the 19.5 acre tract and being the Southwest corner of the 46.12 acre tract:

Thence S 89°53'45" E along a fence a distance of 1332.22' to the point of beginning and containing and containing 49.64 acres of land.
