THENCE N 00°01'04" E a distance of 4529.30 feet with the east line of said 966.25 acre tract and Cochran survey and the west line of the McFarland and Woods Surveys to a petrified rock found for the northwest corner hereof and the southwest corner of that certain 296.5 acre tract of land conveyed to Melba Fay Young by deed recorded in Volume 1425, Page 632 of said deed records;

THENCE N 89°53'28" E a distance of 2985.39 feet to a rock pile found for the northeast corner hereof and the southeast corner of said 296.5 acre tract;

THENCE S 57°36'24" E a distance of 29.05 feet to an iron rod set for a corner on the westerly side of a ranch road;

THENCE along the westerly side of said ranch road the following eight (8) calls:
