Diseased Trees – We have been treating for oak wilt on the property for several years with Arbor Care and Consulting and arborist John Walters. There are pockets of oak wilt in various live and red oaks around the property.

Previous treatment for termites or WDI – A termite infestation in 2020 was eradicated. The service professionals injected insecticide (specific treatment for termites) into the soil and installed an ongoing termite baiting system around the perimeter of the house slab. All damage was mitigated and repaired. There have been no known signs of termites since. Further information regarding the repairs and treatment can be provided upon request.

Previous termite or WDI damage repaired – We replaced any and all wood that was found damaged from the termites.

*A single blockable main drain may cause a suction entrapment hazard for an individual.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.
