Richland Creek serves as the southern boundary providing a year-round water source and wildlife travel corridor. The entire property is susceptible to Richland Creek flooding (partially located in the 100-year AE & Floodway AE) so any type of construction would be difficult. On the other hand, the location couldn't be more convenient being less than two miles south of Interstate 20 and under three miles east of Highway 49.
