

# LEWIS AND CLARK TRAIL RANCH LINCOLN, MONTANA | \$10,000,000



### **EXECUTIVE SUMMARY**

Located in the famed Blackfoot River Valley, minutes from the town of Lincoln, the 2,800± acre Lewis and Clark Trail Ranch combines a near-perfect mix of recreation and production in a locale that rivals some of the best in Montana. Offering a mix of open meadows and forested benches, this well-blocked assemblage provides grazing for up to 150 pairs in the summer months and extensive habitat for big game, including elk, deer, and bear.

Alice Creek, headwaters of the Blackfoot River, meanders for nearly two-and-a-half miles through the property, providing riparian habitat, stock water, and fishing opportunities. Several other small and seasonal streams traverse the ranch, enhancing its scenic and agricultural values.

Complementing its scenic viewsheds, the ranch comes with a complete set of working and residential improvements, including a  $4,720\pm$  square foot, three-bedroom home, working corrals, ranch shop, barn, hay storage, and equipment shed, allowing a new owner to immediately enjoy this superlative Montana offering.


Lincoln, a town of roughly 1,000 people, offers many essential services, including medical clinics, shopping, and a municipal airport, all less than 15 minutes from the ranch headquarters. Known as the gateway to the Blackfoot River Valley, its proximity to the famed Bob Marshall Wilderness Complex provides unparalleled recreational opportunities in one of the lower 48's most expansive roadless areas.
