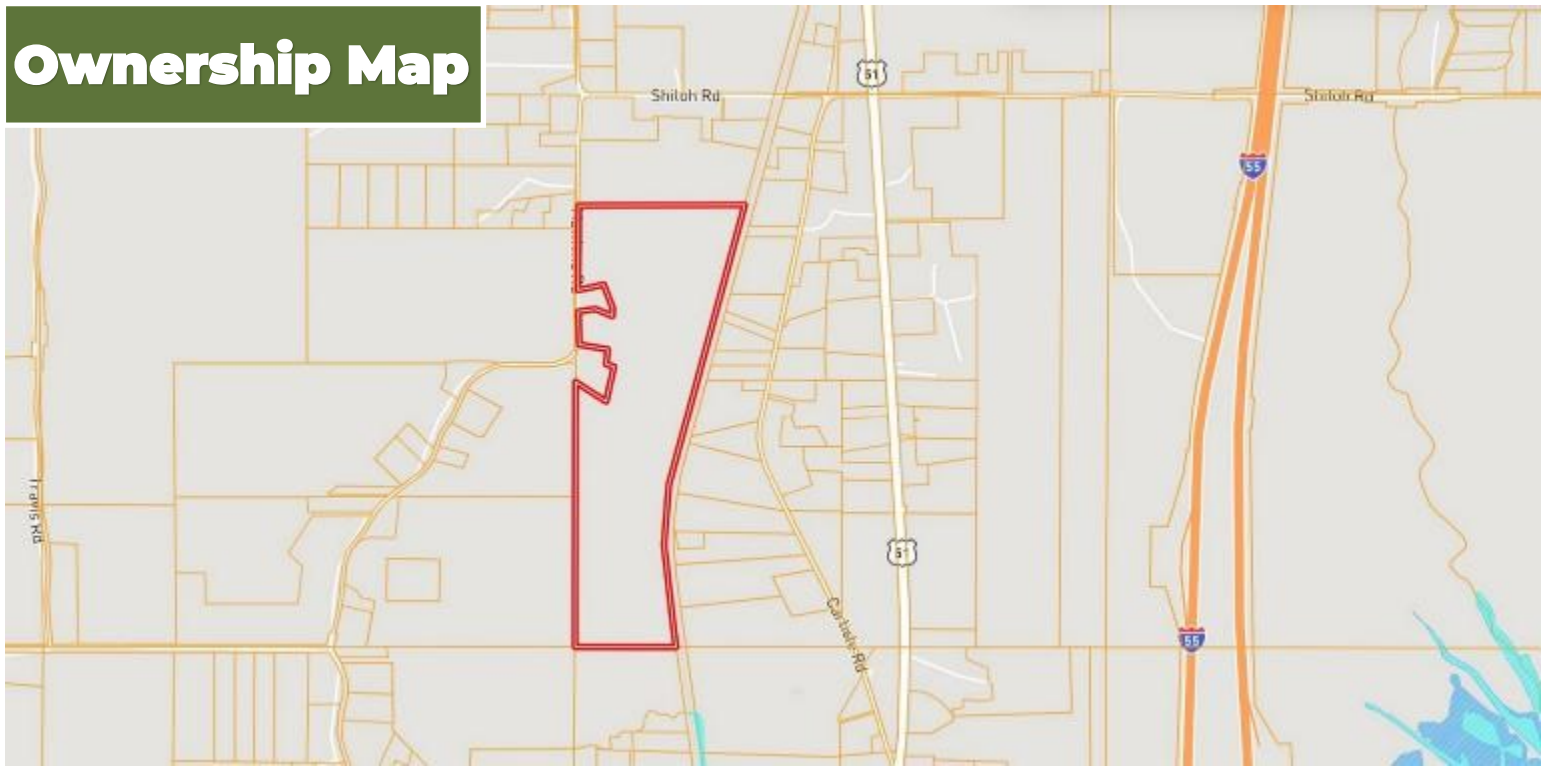

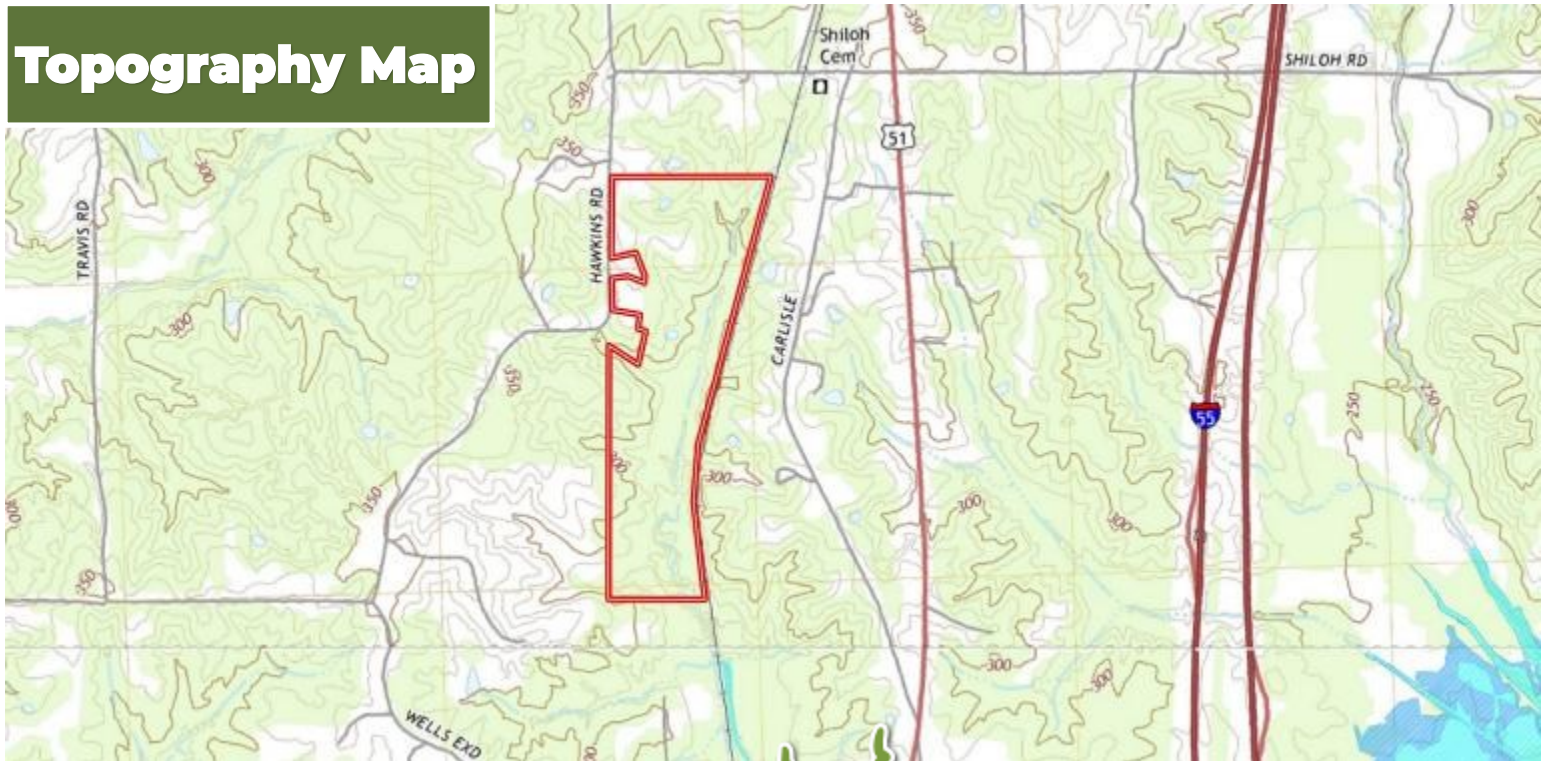




## Ownership Map

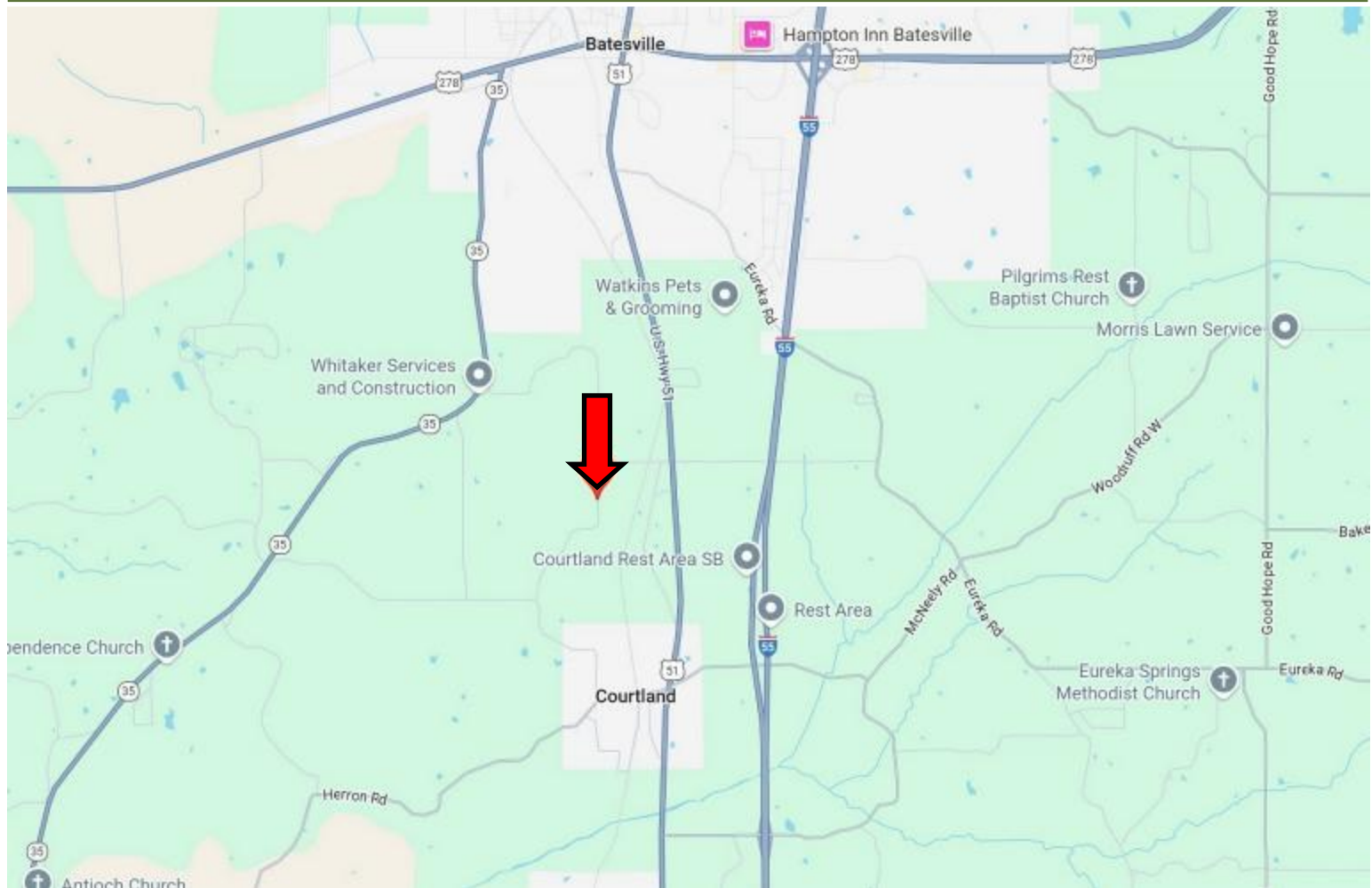
