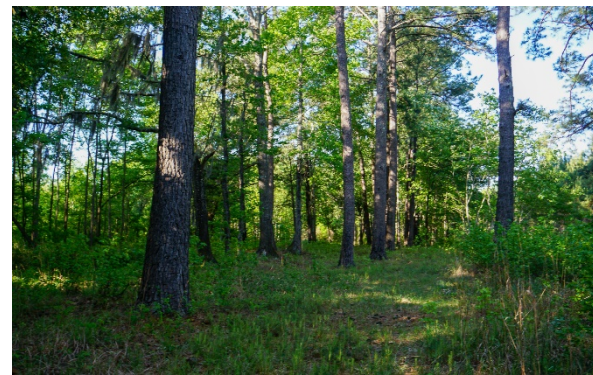

O Euhaw Creek Drive is located approximately 17 miles North of the historic town of Bluffton, SC, and 7 miles Southeast of Ridgeland, SC. The topo is relatively level and comprised of mostly upland loamy soil types suitable for a variety of applications. Historical use has been for upland game bird habitat in conjunction with sustainable forestry management practices. The landscape consists of planted pines and natural pine/hardwood forest. In addition, there are several fallow fields offering a diverse habitat for wildlife. The property boast over 2,000 feet of frontage along Euhaw Creek Drive, 2,000 feet along Strawberry Hill Road, and 1,600 feet along Hwy 462. This is a blank canvas for a variety of potential applications including multiple permanent residential sites, recreational opportunities, long-term investment, or conservation.
